## CANADA VISA REQUIREMENTS

- Application form:** Download online through web link: [visa.eongroup.com.ph](http://visa.eongroup.com.ph). Kindly contact services officer should **log in code** is required.
- Photocopy of Passport Bio Page:** Valid for at least 6 months prior the travel date. Passports shall be on hold by the Embassy for processing until the releasing date. Please manage your travel schedules.
- Photocopy of previously issued visas for the past 5 years:** Found in your passport only if applicable. USA, Schengen, Australia, Japan, Canada, etc.
- 2 Passport size picture:** With Collar. White background. No white-colored shirt/blouse. NO accessories. Neutral face expression. DO NOT STAPLE!
- Photocopy of PSA Birth certificate.** Issued within present year prior to application.
- Photocopy of PSA Marriage Certificate (if applicable).** Issued within present year prior to application.
- Photocopy of Bank Certificate.** \*Available Fund must reflect at least Php 300,000.00 (if applicable).
- Photocopy of Bank Statement.** \*At least 6 months transaction history (if applicable).
- Photocopy of Senior Citizen ID.**
- Photocopy of Credit Card Statements and Limits.** (If applicable).
- Photocopy of Properties. Land Title/s, Car registration, etc.** (If applicable).
- Affidavit of Support.** Notarized.

**\*If supported by Family, Relatives, Friends or Canadian Contact:** Evidence of relationship i.e. Birth Certificate, Marriage Certificate, Photocopy of Passport Bio Page, Invitation Letter, Photocopy of Residence ID.

**\*If Employed**

- Photocopy of Certificate of Employment.** Certificate must reflect the applicant's position, date hired, compensation, office address, office landline number [cellphone is not allowed], email address; must be issued at least 3 months prior to application.
- Photocopy of Latest ITR (Income Tax Return) BIR Form 2316.**
- Photocopy of Bank Certificate.** \*follow the prescribed specifications above.
- Photocopy of Bank Statement.** \*follow the prescribed specifications above.

**\*If owning a Business:**

- Photocopy of Business Registration from the SEC or the DTI.** Valid.
- Photocopy of Business Permit or Mayor's Permit.** Issued in the present year.
- Photocopy of the Latest ITR (Income Tax Return) BIR Forms 1701/1702.**
- Photocopy of Bank Certificate.** \*Follow the prescribed specifications above.
- Photocopy of Bank Statement.** \*Follow the prescribed specifications above.

**IMPORTANT REMINDERS:**

- Mandatory Visa Service Fee & optional Courier Delivery Fee shall be paid upon submission of documents. Prepare more or less Php 1,000.00.
- Documents for photocopying must be printed in A4 sized Bond Paper.
- For proper handling, place all documents in a long folder with name written on cover enclosed in a plastic envelope.
