2. Eon Travel and Tours Corporation will refund only on the following specified reasons below. Release of refund is on the second Friday following the day of approval.
  - a. Natural disasters, terrorism attack & war, political instability, or other external events which will seriously affect, curtail and/or delay the processing of the application.
  - b. Cancellation of Visa Issuance by the country of destination prior the application was processed.
  - c. Other circumstances approved on the management discretion. Request must be forwarded to Operations Manager.
3. The guest authorizes Eon Travel and Tours Corporation or any of its official representatives to process and transact the application. More so, the Embassy does not return any documents submitted by Eon Travel and Tours Corporation except for the passports.
4. The guest shall submit all documents mandatory or additional, deemed required by the institution concerned on or before the deadlines indicated herein. Eon Travel and Tours Corporation reserves the right to refuse documents submitted late and/or do not qualify to the standards prescribed.
