VISA PROCESSING TERMS AND CONDITIONS

1. All applications made are considered guaranteed, thus all fees including Visa and Service Fees are NON-REFUNDABLE. The guest agrees to pay the amount stated under this agreement and waives all rights over all payments made in favor of Eon Travel and Tours Corporation due to:

 - c. Unprocessed application due to refusal and/or late submission of documents after the set deadline.
2. Eon Travel and Tours Corporation will refund only on the following specified reasons below. Release of refund is on the second Friday following the day of approval.
 - a. Natural disasters, terrorism attack & war, political instability, or other external events which will seriously affect, curtail and/or delay the processing of the application.
 - b. Cancellation of Visa Issuance by the country of destination prior the application was processed.
 - c. Other circumstances approved on the management discretion. Request must be forwarded to Operations Manager.
3. The guest authorizes Eon Travel and Tours Corporation or any of its official representatives to process and transact the application. More so, the Embassy does not return any documents submitted by Eon Travel and Tours Corporation except for the passports.
